



INSTRUCTIONS REGARDING MULTIJURISDICTION SALES & USE TAX CERTIFICATE

Dear Customer:

In order to comply with the majority of state sales tax law requirements, Farley's & Sathers Candy Company, Inc. must have in its files a properly executed exemption certificate from all of its customers who claim a sales tax exemption. If Farley's & Sathers Candy Company, Inc. does not have this certificate, it is obliged to collect the tax for the state in which the property is delivered.

If the buyer is entitled to sales tax exemption, the buyer should complete the certificate and send it to Farley's & Sathers Candy Company, Inc. at its earliest convenience. If the purchases are tax free for a reason for which this form does not provide, the buyer should send Farley's & Sathers Candy Company, Inc. its special certificate or statement.

In order for this certificate to be accepted in good faith by Farley's & Sathers Candy Company, Inc., Farley's & Sathers Candy Company, Inc. must exercise care that the property being sold is of a type normally sold wholesale, resold, leased, rented, or utilized as an ingredient or component part of a product manufactured by the buyer in the usual course of its business. Should Farley's & Sathers Candy Company, Inc. fail to exercise care, it could be held liable for the sales tax due in some states or cities. Misuse of this certificate by Farley's & Sathers Candy Company, Inc. as a seller, lessor, or its buyer, lessee or a representative thereof may be punished by fine, imprisonment, or loss of right to issue certificates in some states.
